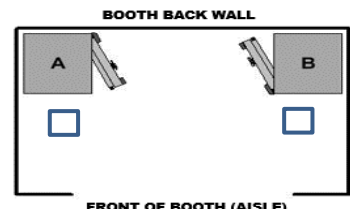
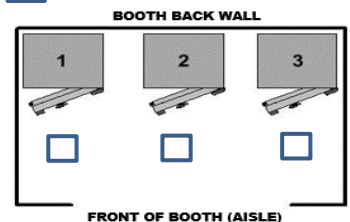
- PAYMENT S:** Payment must accompany order form and completed before show start date. Receipt and confirmation is sent to email address on form. Please allow 48 hours for email confirmation.
- SAFE INSTALLATION POSITION REQUIRED:** Indicate your choice of safe position on the chart provided to right. For special installation position, please submit booth diagram. Position is **MANDATORY** and **REQUIRED** before confirmation may be emailed.
- CHANGES IN BOOTH NUMBER, SAFE MODEL, OR SAFE POSITION:** Exhibitor is solely responsible for notifying Rolland Safe & Lock L.L.C. (Rolland) of any changes **no later than 5pm CST, 4-19-19**. Rolland will confirm any changes via email to email address on form.
- SAFE COMBINATION:** All rental safes are equipped with Pushbutton Digital Lock, one (1) padlock and two (2) padlock keys. Exhibitor can program digital lock with own confidential combination code. For any lost/misplaced keys, there is a \$50 cash fee for padlock replacement.
- CANCELLATION:** Order may be cancelled no later than 4-26-19 without penalty. After 4-26-19 safes will be in the transport stage and ineligible for refund.
- ONSITE:** Techs available for onsite assistance during show hours. Please visit service desk for any service requests. Safe reposition after initial will incur \$200 fee and must be requested at Service Desk. Safe moves require 2 technicians/equipment and 2-4 hours to complete.
